Generic Marking Principles

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

GENERIC MARKING PRINCIPLE 2:

Marks awarded are always whole marks (not half marks, or other fractions).

GENERIC MARKING PRINCIPLE 3:

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit
 is given for valid answers which go beyond the scope of the syllabus and mark scheme,
 referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

GENERIC MARKING PRINCIPLE 4:

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

GENERIC MARKING PRINCIPLE 5:

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

Section A

Question 1

Discuss the ways in which the extract from *Agent Carter* constructs meaning through the following:

- camera shots, angles, movement and composition
- sound
- · mise-en-scène

• editing. [50]

Candidates will be assessed on their ability to understand how meaning is constructed in a media text through the analysis of different technical areas.

Marks are awarded for three different criteria:

Explanation/argument/analysis (max 20)

Use of examples (max 20)

Terminology (max 10)

Candidates' work should be judged on each of these criteria, and marks awarded according to the level attained. It should be noted that it is possible for a candidate to achieve a different level for each assessment criterion.

A positive approach to marking is encouraged. Reward alternative valid responses.

Specific notes on the sequence - likely areas of coverage

Camera:

- widescreen and its impact, especially in opening flashback
- establishing shot of New York (one year later) use of crane
- use of close-up in opening sequence; track in to Peggy's face as reaction to patronising male

Sound:

- Use of dialogue
- Music in opening and incidental at later points
- Ambient sounds- the fight sequence, the alarm
- Peggy's British accent v US accents
- Diegetic sound of radio on location sequence

Editing:

- Flashback sequence at start and 'one year later' establishment of time in sequence
- Shot/reverse shot at various points
- Establishment of space and 180 degree rule

Mise-en-scene:

- dress of male characters v Peggy carter
- wood panelled setting of office
- lighting and colours,
- positioning of characters in office scene
- body language and facial expression- patronising males
- emphasis on detail
- photo of Steve that she looks at
- darkness and phone call; red light on face
- confrontation sequence

- Peggy's past relationship;
- her professionalism v sexist male order;
- Peggy's ability to go it alone

- use of terminology [10 marks]

Candidates' work should be judged on each of these criteria individually and marks awarded according to the level attained. It should be noted that it is possible for a candidate to achieve a different level for each assessment criterion.
