- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.

- All the marks on the mark scheme are designed to be awarded. Examiners should always award full marks if deserved, i.e. if the answer matches the mark scheme. Examiners should also be prepared to award zero marks if the candidate's response is not worthy of credit according to the mark scheme.
- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification may be limited.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, the team leader must be consulted.
- Crossed out work should be marked UNLESS the candidate has replaced it with an alternative response.

	<ul> <li>Limited liability means they are not risking personal assets.</li> <li>Elliot and Adam may be more willing to take chances in developing SSL.</li> <li>SSL is a private limited company with three shareholders.</li> <li>Elliot and Adam were initially only risking the £6 000 they borrowed from their parents.</li> <li>Elliot and Adam still own 98.8% of SSL, Chairman, Robert Easton was sold 1.2% of the company.</li> <li>Limited liability reduces risk for potential shareholders and therefore they will be more willing to invest.</li> <li>Setting up and running with limited liability means SSL will have a wider access to other types of finance.</li> <li>However, limited liability may make it more difficult to obtain finance or trade credit because suppliers may not be able to get all their money back if the business fails.</li> <li>Elliot and Adam have to register SSL's accounts with Companies House so competitors can have access to its accounts.</li> </ul>	(8)
